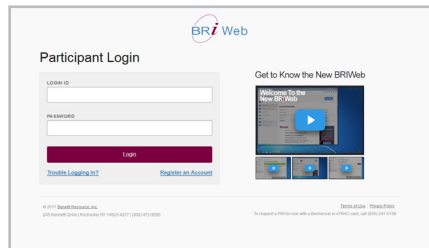
BRiWeb

BRiWeb is your secure online participant login for managing your accounts with Benefit Resource.

Key features include:

- View balance and transaction information
- Update email address for receiving important notices and alerts
- Set up a direct deposit account to receive your account reimbursements faster
- Submit claims and supporting documentation
- Resolve receipt requests: upload receipts, submit substitute claims or repay an expense
- Enroll and/or change elections (if available)
- Download forms and other important plan documentation
- Access Eligible Health Care Expense lookup table

Member ID: Default Login ID selected and provided by your employer.

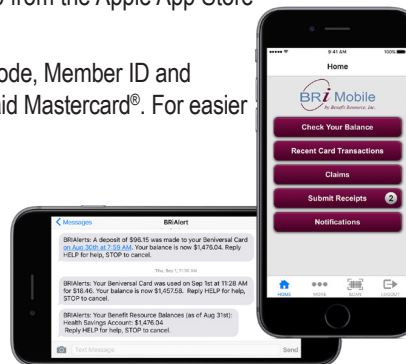
BRiMobile

BRiMobile provides on-the-go account access for viewing balances and recent transactions, submitting claims, uploading receipts and more. Download the BRiMobile app from the Apple App Store or Google Play.

To log into the BRiMobile app, you will need either your Company Code, Member ID and Password or your Beniversal® Prepaid Mastercard® / eTRAC® Prepaid Mastercard®. For easier future logins, you can create a PIN passcode.

BRiAlerts

BRiAlerts provide real-time text¹ or email notifications regarding the status of your accounts. From deposit and balance alerts, to transaction notifications that make you instantly aware if additional documentation may be required, BRiAlerts puts more information in your hands.



Tips for Managing Your Accounts

- **Check your balance.** Before making a large purchase and on a routine basis, be sure to check your balance.
- **Set up a direct deposit account.** You can receive your reimbursements faster by setting up an account for direct deposit reimbursement.
- **Be aware of any deadlines.** Check your plan documentation to see when eligible services must be provided and submitted.
- **Save your receipts and documentation.** Pre-tax benefit accounts are governed by the IRS and may require proof that funds were used for eligible expenses.
